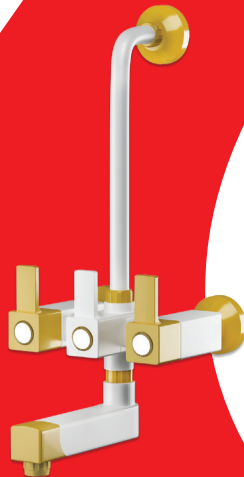

TERMS OF WARRANTY

PRINCE PIPES AND FITTINGS LIMITED ("PPFL") Authorized Retailer will repair/ replace functional parts & components, FREE OF COST if it proves to be of defective material or workmanship within the Warranty Period from the point of Purchase (Dealer Counter) against Invoice. Onsite visit service is not covered under Warranty.

PPFL Dealer reserves the right to examine the product, which is in question and its installation (if needed), prior to the repair/ replacement and replacement of any part that proves defective in material and manufacturing workmanship under normal installation, use and service.

PPFL will not be liable:

- For any damage due to faulty installation, the expenses incurred with regards to deputing the service personnel towards Visit Charges, to & fro travel, conveyance and other incidentals which will be borne by customer.
- For any plumbing, civil or construction work required during installation of new products or replacement/repair of old products.
- In case the damage is due to improper handling, operation, maintenance or lack of maintenance; the warranty conditions shall not be applicable.
- When product is not installed as per the guidelines given in instructions.
- Defects are caused due to uncontrollable situation like act of God, lightning, abnormal water supply/pressure/temperature, contaminated water, hardness of water beyond the acceptable limits of drinking water or while in transit from dealers' outlet to buyer's place of installation.
